#### Counseling/Admission of M.Ed. for vacant/leftover seats in Colleges of Education:

- 1. If the seats after counseling for M.Ed. programme under Self-Financed Scheme College of Education affiliated to Indira Gandhi University, Meerpur-Rewari still remain vacant, the college concerned will have to display the vacant seats on the website of the college.
- 2. The concerned college may make admission at its own level in the presence of the Observer of the University upto 28.01.2021 (upto 05:00PM) by adopting procedure as laid down by the University.
- 3. The candidates have to apply afresh and required to submit the application with late fee of Rs. 2000/- along with prescribed fee to the Principal of the college concerned.

4. The Principal of the college will have to send/deposit fee received from the candidates to the University upto 29.01.2021 (upto 05:00PM) positively alongwith list of admission made otherwise the admission made by the college concerned will be treated as cancelled.

Note: After completion of this phase, no further counseling shall be conducted by the University for admission and no college shall be allowed to make admission beyond 28.01.2021 even if seats remain vacant, to meet the minimum requirement of 200 days compulsory teaching as per NCTE norms. Further, the Hon'ble Punjab and Haryana High Court, Chandigarh has decided in the CWP No.-25707 of 2015 that once the last date has been notified by the admission making authority, therefore, there would be no extension under any circumstances.
